# March 10<sup>th</sup> 2020 – Public Minutes

1. The Chair called the meeting to order. (4:02 PM)

# **Police Services Act:**

- 35 (4): The board may exclude the public from all or part of a meeting or hearing if it is of the opinion that,
- (a) matters involving public security may be disclosed and, having regard to the circumstances, the desirability of avoiding their disclosure in the public interest outweighs the desirability of adhering to the principle that proceedings be open to the public; or
- (b) intimate financial or personal matters or other matters may be disclosed of such a nature, having regard to the circumstances, that the desirability of avoiding their disclosure in the interest of any person affected or in the public interest outweighs the desirability of adhering to the principle that proceedings be open to the public. The Chair said he was delighted to learn that Mark Graham has been reappointed to the Board. He also welcomed Les Kariunas. Mr. Kariunas has a wealth of experience in business and human resources.

Les Kariunas informed everyone that he has worked for international companies, has experience managing teams and has an international risk management designation. He is looking forward to a collaborative approach and bringing forward some change.

#### 8. <u>Delegations and Presentations:</u>

Sheldon Laidman, Commissioner of Community Services for the City of Peterborough

Mark Graham asked Mr. Laidman if the Board has to endorse the plan as it is a requirement in the **Police Services Act**.

Mr. Laidman believed it is up to Council; however, it should be endorsed by the Board as well.

Les Kariunas asked who the stakeholders are and what is expected of the Board.

Mr. Laidman said the Community Wellbeing Plan (CWP) was more formalized and there was a steering committee. We are trying to decide if we follow the same process this time. There will be a time line as to how we engage with stakeholders.

Chief Gilbert said he and the Chair attended a meeting about this last February.

Sheldon Laidman informed everyone that the townships felt enough background work was done on the CWP. The OPP were also at the table for that discussion.

Les Kariunas asked how the Service is dealing with the COVID19.

Chief Gilbert explained that the Employee and Family Assistance Plan has provided video training. We are staying abreast of the situation and communicating with Members and the Health Unit.

Mark Graham said the CMHA are advising against travel.

Diane Therrien said she spoke with Council and Dr. Salvaterra last night. Information is changing but they are being updated. We encourage everyone to be vigilante.

Gary Baldwin asked Chief Gilbert how many new recruits we are sending to the Ontario Police College for the May intake and how many can retire.

Chief Gilbert said we are sending two in May and there are possibly 19 Members who can retire in '21.

There was discussion about the province's five year anti human trafficking strategy:

- There are a number of agencies who could be involved.
- The Service has a special victims unit as of last July which will help us to obtain grant money.
- We have not seen the framework for this yet and how or when the funding will become available. There will be meetings in the next three weeks to discuss funding for this initiative.

The Board was in favour of the Chair writing and endorsing the recommendations. The proposal was well thought out and we need to have local partners.

#### 16. Safe Consumption Site

Moved by Bob Hall Seconded by Mark Graham

Whereas the Peterborough Police Services Board values activities that support healthy, vibrant and safe communities;

Whereas Peterborough is experiencing elevated rates for opioid related deaths and hospitalizations related to opioids affecting individuals, families and the overall community;

Whereas the Peterborough Police Services Board is a partner in the Peterborugh Drug Strategy that takes a collaborative approach to dealing with issues and harms associated with substance use based on the four pillars of prevention, harm reduction, treatment and enforcement; and

Whereas the model of providing wrap-around services, including treatment and support services, in the same space as supervised consumption services reflects the principles of the Peterborough Drug Strategy's four pillars approach;

Therefore, be it resolved that the Peterborough Police Services Board endorses the wrap-around services model for consumption and treatment services sites as a way to support healthy, vibrant and safe communities dealing with opioid substance use. – CARRIED

Bob Hall handed this motion out and explained that he is being asked about the safe consumption site by members of the community. He spoke about the drug strategy and four pillars. We must ensure that the community's need is included in the site with wrap around services.

The Board felt that the province would not support a consumption site without wrap around services.

# 17. <u>Conference Updates</u>

Bob Hall:

- The summit was a smaller conference where much of the focus was on bargaining, trends, benefits etc.
- Presentations were excellent.

Gary Baldwin and Niquel Pritchard Pataki:

- Good conference with a variety of topics.
- The Doering decision is now the benchmark in policing regarding police dealing with intoxicated people.
- There were harassment case studies.
- Discussion about what is administrative vs. operational between Chiefs and Boards.
- Longer contracts appear to be the norm in collective bargaining which allows us to spread the cost over a longer period of time.

The Chair explained that Jeeti Sahota, Chief Gilbert and Woody McKaig will do Board training for us. Three hours is most likely needed. The Chief will bring in Members of the Service as well.
